## Vuela

SW Barber St. - Wilsonville Housing Authority of Clackamas County | Palindrome Properties Group

Vuela is a development of 121 apartments created by Palindrome Properties Group and the Housing Authority of Clackamas County. The project will include homes ranging in size from one to three bedrooms for people who earn 30% to 80% of the area median income. The development also includes 20 permanent supportive housing units supported by Metro Permanent Supportive Housing Pilot funding.

By combining permanent supportive housing units with affordable apartments, Vuela meets the needs of people with low income and those with higher need who have experienced prolonged homelessness in addition to an intellectual or physical disability.

Vuela has been designed to maximize access and security for residents and includes features like a guest intercom, wide hallways for move-in and airy common spaces with complimentary Wi-Fi access. Each unit will be equipped with a permanent wall air conditioning unit.

Vuela is located within a half-mile of employers, natural areas and parks, and the City's planned I-5 Pedestrian Bridge connecting Wilsonville's west and east sides. Major commercial amenities are within a one-mile radius, including grocery, pharmacy, numerous restaurants, financial services, health and fitness. Wilsonville Town Center and its surrounding area offers Safeway, Wilsonville City Hall, Clackamas Community College and Wilsonville Community Center and Memorial Park.

Because of its convenient access to the Wilsonville transit center, Vuela appeals to people of color who utilize public transit at rates higher than white adults. Palindrome has created a resident services plan with partner nonprofit organization Latino Network to provide referrals and culturally responsive programming, including health and wellness education, legal services, and arts and culture activities. Clackamas Women's Services will support prospective residents through the referral and application process for Vuela's permanent supportive housing units.

## Development program

Vuela is an affordable housing community with 20 permanent supportive housing apartments and 100 affordable apartments set at 30% to 80% area median income.
