# Nature in Neighborhoods nature education and outdoor experiences grants review committee

Metro is recruiting people to review Nature in Neighborhoods nature education and outdoor experiences grants and to help re-envision and design the Nature in Neighborhoods community grants program. This is a stipended volunteer opportunity.

Members of the committee will help to recommend up to \$750,000 in grants to community organizations and groups seeking to support and create partnerships in local communities. These grants advance resiliency to climate change and racial equity, diversity and inclusion goals through nature education or outdoor experience programs serving school-aged children to elders, job training and life skills for youth, and outreach and engagement programs for residents from around the region.

It's important to have a broad diversity of experience and backgrounds represented on the review committee. Grant applicants are eligible to serve on the review committee; reviewers must disclose any conflicts of interest. The Metro Council makes all final funding decisions.

To apply, send a simple email and attach a resume or experience summary describing your relevant professional and/or lived background and experience.

Metro staff will begin reviewing committee applications in September 2024 and review committee applications are due by October 15, 2024.

### Nature in Neighborhoods community grants program re-envisioning committee

Review committee members will have the option of also participating in a program re-envisioning process slated to begin in spring 2025 and extend through the 2025 funding opportunity. The goal of the re-envisioning process is to create a revised program structure that is responsive, supportive, and grounded in the needs and priorities of the communities served by this grant program. Like the review committee, this is a stipended volunteer opportunity.

The re-envisioning process is still taking shape, but will include elements of:

- **Community engagement** participants will be channels for the voices of our wider communities. This will involve having conversations with people in our communities about their own relationships to nature and sharing these insights with the broader committee in the program redesign process.
- **Government system analysis** participants will look at current government structures and systems in place and make recommendations for how to improve the community grants program, while also working within legal and administrative constraints.
- This process will be highly relational and experiential. It's important that committee members have a willingness to try new things, be vulnerable, empathize, work through conflict, listen well, feel, and receive feedback.

Committee recommendations for the re-envisioning will be generated from the collective interaction of individual ideas and experiences. It's important for committee members to have experience passionately holding and sharing their own ideas, while also being open toother ideas and feedback from others. This capacity to hold both/and will support the committee in creating a recommendation that is emergent from the group process and can create the best outcome for our communities. There will be limitations to what this program can do and we want to create the best outcome within those constraints.

Metro is looking for people with backgrounds in nature education, outdoor experiences, climate resiliency, cultural programs, mentorship and job skill development, racial equity, diversity and inclusion, community partnership development, philanthropy, grant management or related fields. In selecting members for this committee, Metro seeks a mix of members who bring experience or interest in:

- Reviewing or writing grant proposals and offering suggestions on ways to strengthen programs
- Projects that involve a wide range of partners and funding
- Projects that engage diverse community groups

## **GRANT REVIEW COMMITTEE DUTIES**

- Serve a one-year term with an opportunity to be reappointed.
- Review up to approximately 30 pre-applications in **October/November**, and 20 full applications in **December/January**.
- Evaluate applications based on the information submitted; the purpose, goals and evaluation criteria; and the review committee's professional and collective judgment.
- Attend one virtual review committee orientation meeting (1 ½ hours)
  - o Virtual review committee orientation meeting: Thursday, October 24th, 10 to 11:30
- Attend two virtual review committee meetings (4 hours each).
  - Pre-application virtual review committee meeting: Tuesday, November 13th, 1 to 5
  - o Full application virtual review committee meeting: Tuesday, January 23rd, 1 to 5
  - The orientation and application review meetings will be fully remote.
- Develop funding recommendations together with other review committee members.
- Provide feedback to staff about ways to strengthen the grant program administration and outcomes.
