Introduction: A History of the Tri-County Local Government Commission

In 1975, former Staff Director of the Portland Metropolitan Study Commission (PMSC) and Assistant Director of Columbia Region Association of Governments (CRAG), A. McKay Rich, assembled an ad hoc team to apply for a National Academy for Public Administration competitive \$100,000 grant to study multi-level government in metropolitan areas. This money was provided by the United States Department of Housing and Urban Development (H.U.D). The team included Ron Cease (chair and professor of political science at PSU and first chair of the Boundary Commission), Jerry Tippens (journalist), Larry Sprecher (Beaverton city manager), and Don Carlson (Boundary Commission director).

The National Academy for Public Administration wanted equal attention given to metro-level institutions and local neighborhood empowerment, but without consensus on local issues, the focus of the National Academy turned to designing an upper-tier body. In Phase I of its program (starting in May 1972), the National Academy had previously supported government reorganization studies in Rochester/ Monroe County, New York, and Tampa Bay, Florida.

Phase II of the program consisted of choosing two metropolitan areas for study by "citizen panels" of two-tier governance models. The panel was required to include all major social and economic groups and have representation from elected officials. Its objective was to produce a plan that could be implemented. Its work was to involve extensive public consultation and public education.

McKay and his team submitted the grant application through the Portland Metropolitan Area Local Government Boundary Commission on July 9, 1975. They learned that Portland was a semi-finalist, along with Seattle, Washington and Trenton, New Jersey, Denver, Colorado and Memphis, Tennessee. After the National Academy's site selection committee visited the five areas in October 1975, Portland and Denver were chosen. In a memorandum dated November 7, 1975, Phil Balsiger, Chairman of CRAG announced that the Boundary Commission had been awarded the grant to study local government structure in the CRAG region. As a condition of the grant, \$50,000 in local matching funds had to be raised. In response, an Executive Committee consisting of twelve members was organized, drawing on individuals with past PMSC experience to lead the effort, including Ron Cease (chairman), Carl Halvorson (vice-chair and former president of the Portland Chamber of Commerce), and A. McKay Rich (staff director). Both in-kind and financial contributions were successfully raised, contributed by Portland State University (PSU), Columbia Region Association of Governments (CRAG), the Boundary Commission, and various corporations and municipalities.

In November and December 1975, the "Ad Hoc Two-Tiered Planning Committee," the formal entity that received the grant, evolved into the Tri-County Local Government Commission. The Boundary Commission sent letters to laborers, chambers of commerce, civic groups, associations and other organizations and from the responses, 65 people were chosen from diverse backgrounds and professions to serve on the Commission for an anticipated 18-month period. Commission staff members were also hired, including Barbara Garbutt (administrative secretary) and Bill Cross (Public Information Coordinator).

One of the Commission's first priorities was to define its Statement of Purpose which read as follows:

The Tri-County Local Government Commission will examine the existing structures of local government in the Portland metropolitan area, the services provided, and the needs of its people and they will pursue whatever improvements the commission may identify. In fulfilling its responsibility, the Commission will endeavor to advance equity, efficiency, economy, responsiveness, visibility, accountability, citizen participation, political feasibility and actual service needs.

As the work commenced, Commission members were tasked with studying urban needs and services and assessing which were better implemented on a regional level and which were best performed by local jurisdictions. In addition, Commission members were to make recommendations for the implementation of such a two-tiered government. Their work was divided into three phases:

Phase I: Organization, Orientation, and Problem Identification

The first phase focused on "problem identification". In approaching this work, the Commission organized several committees:

- Finance and Taxation
- State-Local Relations
- Regional Governments and Agencies
- Local Government and Intergovernmental Relations
- Neighborhood Organizations and Citizen Involvement

In addition, a Public Information Program was established to communicate with the public and produce reports.

At an April 10–11, 1976 conference (the "Coast Conference"), the Commission adopted broad policy guidelines as criteria for whatever reform proposals might be considered in Phase II, including the following:

- Services should be offered at the lowest level of government at which they can be economically, responsively, and efficiently provided.
- Unnecessary units of governments should be consolidated.
- Service delivery must be integrated to be understood and supported by citizens and governments. An integrated system of coordinated priority-setting, planning, and equitable financing for the tri-county area is needed. Unfunded state mandates should be avoided.

The conference asked for two models of governance to be studied in Phase II:

- "Model II" a two-tier government similar to Toronto would entail the consolidation of the three counties into a single metropolitan county (considered the "long-term, more ideal" approach), and
- "Model III" a three-tier arrangement like the Twin Cities which would superimpose a metropolitan service body over the existing counties and municipalities (considered to be more feasible in the short term).

Two other models were considered:

- "Model I" referred to the status quo, that is, the CRAG council of governments, and
- "Model IV" the organization of area-wide single-purpose districts.

In all cases, the upper tier was expected to be selected.

Phase II: Analysis of Problem Areas

In launching the second phase, the Commission concentrated its efforts on designing a simplified system of area-wide governance that would reduce the number of existing governments, but still attend to the common needs of the entire metropolitan community. This emphasis was in large part due to the Commission's perception that of all the problems identified, the proliferation of special-purpose regional agencies governed by appointed officials posed a serious problem that was receiving little consideration from other organized groups and governmental entities.

Hence, the Commission believed it could make its most significant contribution in this area and focused its efforts on developing an action plan that would create no new level of government and that could be submitted to the Oregon Legislature. A series of functional "task forces" were established to study and compile information to formulate the Commission's recommendations:

- Human Services
- Public Works and Transportation
- Land Use, Recreational, and Cultural Activities
- Public Safety, and
- Finance, Taxation, and Administrative Services.

After holding nearly 200 meetings with subject matter experts, citizens, public officials, administrators and community organizations representatives, the Commission drafted its final recommendation on restructuring regional governance at a conference held October 2–3, 1976. At the conference a Long-Range Options Committee was established to study ideal options without regard to immediate feasibility. This involved study of the London County Council, Metro Toronto, and Miami-Dade. The committee produced a "conceptual model" of a two-tier system. The upper tier would be a consolidated, area-wide government replacing the counties. The lower tier would be a series of "corporate communities" - total coverage of incorporated municipalities and the elimination of unincorporated territory.

Phase III: Implementation of Recommendations

The last phase of the Commission was focused on implementing the regional governance proposal and to developing final recommendations on city-county relationships, special districts, the neighborhood movement and long-range alternatives. In addition, the Commission worked to communicate its recommendations to the public and to government to ensure enactment. Citizens were generally understood to support the idea of an elected Tri-County Council, while local elected officials were more guarded.

A "Critical Questions" conference held in December 1976 was widely attended and appears to have resulted in agreement on a legislative proposal.

The Tri-County Local Government Commission concluded that there was a need for legislative changes to Columbia Region Association of Governments (CRAG) to create a more accountable decision-making body, broaden its powers and responsibilities, and grant taxing authority. However, the Commission recommended that instead of bolstering CRAG, the Metropolitan Service

District (MSD)¹ should be reconstituted and reorganized by merging the service functions of the MSD with the planning functions of CRAG into one umbrella agency.

Further recommendations included: that the new agency should have a council elected from districts that coincide with traditional communities; it should have elected executive officers; and it should assume the planning functions of CRAG. Furthermore, additional responsibilities could be added to the new agency's jurisdiction through voter approval. The stipulation regarding elected officials was designed to provide enhanced public accountability by the council members, and to encourage regional thinking over local interests, which had been a major point of contention with CRAG. However, the council members were to remain part-time employees of the agency and were to be paid per diem for their duties (based upon meeting s attended).

The core of the Commission's proposal was incorporated as H.B. 2070 by the House Interim Committee on Intergovernmental Affairs for introduction in the 1977 legislative session. One significant deviation from the Commission's proposal and the House Bill was the reduction of territorial jurisdiction from the full Tri-County area to an area corresponding to the urbanized zone and its immediate surroundings. This new area was similar to, but did not correspond to, the Metropolitan Service District (MSD) boundary at the time.

H.B. 2070 was passed by the House and Senate in July 1977 with the stipulation that it be referred to Portland metropolitan voters in the May 1978 primary. With little organized opposition, Ballot Measure 6 – "Reorganize Metropolitan Service District, Abolish CRAG" – passed by 20,000 votes.

With the passage of House Bill 2070, the Tri-County Local Government Commission concluded its activities and officially closed its base of operations at Portland State University on June 30, 1978.

¹ The Metropolitan Service District (MSD) was a multi-purpose government that was authorized to perform the following services in the Portland metropolitan area related to sewage treatment and disposal, control of surface water and solid waste disposal, public transportation, and operation of the Washington Park Zoo. On May 26, 1970, tri-county voters approved Ballot Measure 2 forming the MSD.

This collection documents the work of the Tri-County Local Government Commission from its inception in late 1975 to the completion of its work in 1978. For many years, this collection remained in storage unprocessed. Becky Shoemaker Metro Records Officer /Archivist set the collection aside and reserved it for archival processing.

In 2009, Zack Taylor, a doctoral candidate from the University of Toronto came to Metro to conduct research for his dissertation on postwar planning for city-regions. Among other materials, Mr. Taylor reviewed the contents of this collection and volunteered to produce a preliminary inventory of its contents. His work contributed to the creation of this finding aid.

During his review of the records, Mr. Taylor speculated that the contents of this special collection belonged to Commission member Corky Kirkpatrick, who served on the Commission's Finance and Taxation Committee. As such, the degree to which the collection represents the complete history of the Tri-County Local Government Commission cannot be verified.

This collection, which is largely comprised of meeting records, has been completely digitized and is available to the public via Metro Online Records.
